**RE: NOTICE OF ENTRY SUMMARY DECLARATION SURCHARGE  
(SURCHARGE CODE: ENS)(TARIFF CODE: 301,303,305)**

With the EU Customs Cargo Advance Security Rules, COSCON decide to implement ENS (Entry Summary Declaration surcharge) for all shipments from Far East and IPBC area to European countries with effective fm Jan 1<sup>st</sup> 2011 (sailing date) . The details are asf:

1. The rate of ENS is **USD25 per bill of lading** to cover the daily COSCON additional operation cost of the new rules. In case customer requests a manifest amendment after we lodged Entry Summary Declaration with EU Customs, **USD40 per bill of lading** will be implemented.
2. **The above surcharge will be prepaid** for shipments destined to below countries:
